Memorandum of Understanding

BETWEEN

D. E. SOCIETY'S SMT. SUBHADRA K. JINDAL COLLEGE OF NURSING, PUNE, having its office at Fergusson College Campus, Fergusson College Road, Shivajinagar, Pune-411004, represented by duly authorized signatory, Dr. Sharada Chavan, Principal, Age - 45 years, Occupation - Service, residing at Flat No.303, Ramesh Park, Sukhsagar Nagar, Pune-411 048.

D. For mutual benefit, the parties here to agree that for imparting of practical training and examination of the students as contemplated by the concerned syllabus , the said college shall send students up to its intake capacity, in batches each comprising about 20-30 students led by its faculty members to the said Hospital in consideration of the said college paying an amount of Rs.1000/- (Rs. One Thousand only) per student per month during the period of their practical training and according to other terms and conditions enumerated below:

NOW THIS MEMORANDUM OF UNDERSTANDING WITHNESSETH:

1. SCOPE:

The scope of this understanding extends only to deputation of the students by "D. E. SOCIETY'S SMT. SUBHADRA K. JINDAL COLLEGE OF NURSING" up to its intake capacity for all courses, for imparting of practical training and examination as contemplated by the concerned syllabus for the discipline, in batches, each comprising of about 20-30 students led by its faculty members to the said hospital and other incidental and ancillary matters related thereto.

2. DURATION:

2.1 The duration of this understanding shall be for a period of Three Academic Years i.e. 2025-26, 2026-27 & 2027-28 (03 yrs.) unless expressly extended.

2.2 Both the parties can cancel or terminate the present MoU by giving Three Months prior notice in writing to each other.


3 AGREEMENT:

3.1 JEHANGIR HOSPITAL hereby agrees and permits the D. E. SOCIETY'S SMT. SUBHADRA K. JINDAL COLLEGE OF NURSING to depute students up to its intake capacity in batches, each comprising of about 20-30 students led by its faculty members to the said hospital for imparting of Practical training and Examination of students as contemplated by the concerned syllabus. Jehangir Hospital shall accommodate students as per its capacity.

3.2 The said college shall acquaint the students with the norms of discipline to be followed while on the campus of the said Hospital with appropriate notice that in case of any

indiscipline by any of the students, the Hospital shall have right to restrict her/ him from visiting the said Hospital.

- 3.3 The said college is permitted to hold its practical and/or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said Hospital.
- 3.4 The parties shall maintain a register of students attending the said hospital for recording the attendance of the students and the said register shall be verified by the faculty members accompanying the batches and any authorized staff of the said hospital.
- 3.5 The said register shall remain in the custody of the said college and for each experience, it shall be brought to the said hospital for verification by the parties in terms hereof.
- 3.6 The said college shall designate one of their officials with adequate responsibility, accountability and authority as a single point interface to license with JEHANGIR HOSPITAL on all issues pertaining to the smooth operations of the practical training component of the COURSE. Communicate his/her name, of execution of contact address telephone number and Email ID or any change there to, to the JEHANGIR HOSPITAL within 15 days of this agreement.
- 3.7 The said college shall ensure that the students and the training provider will not disclose any confidential information / data of the patients. The medical information /data of the patient received during the training period shall be used only for the academic use. The college and its students shall not disclose patient related facts during and/or after the course and training to the patient or to any third party without prior written consent.
- 3.8 The said college is only responsible for any legal consequences initiated due to such breach.

4 CONSIDERATION :

4.1 In consideration of this MoU, the D. E. Society shall pay and / or causes to be paid through the said college an amount of Rs.1000/- (Rs. One Thousand only) per student per month during the period of their experience to the said Hospital. The payment made for each student is non-refundable. Such payable amount will be paid to Hospital irrespective of the fees collected from the student.

4.2 Limitation of time for payment:

It is agreed by and between the parties that after the expiry of the month in which training was imparted to the students by the said Hospital, the D. E. Society shall pay the

amount to be calculated as per the number of students within 07 days from the date of expiry of each month. If the D E Society fails or neglects to pay the amount to the said Hospital consecutively for 3 months, in such case said Hospital will be entitled to revoke / cancel the present MoU by sending written letter by registered post A/D or by Courier Service to the D. E. Society on this behalf.

In the event that a student/ assigned to JEHANGIR HOSPITAL drops out during the month, said college will endeavor to replace that student with a new student. However, the said college shall pay the total monthly consideration to the Hospital even to the drop out student.

4.3 It is agreed by and between the parties that the party of the first part shall make the payment to the party of the second part by account payee cheques to be drawn in the name of "Jehangir Hospital" or Online payment through RTGS/NEFT.

5 OBLIGATIONS :

- 5.1 The D E Society, the said college and the faculty leading the batches shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the campus of the said Hospital.
- 5.2 Since the matter relates to the academic year of the concerned students of the said college, except in cases of gross indiscipline and misdemeanor, the said hospital shall not restrain the students deputed in the terms hereof.
- 5.3 In the very nature of the matter, the parties here to undertake to extend all necessary co-operation to each other, so that the education of the students of the said College and the treatment and care of the patients of the said Hospital is not hampered.

6 MISCELLANEOUS

- 6.1 Confidentiality information: Information shall be strictly kept confidential by the either party and its employees and affiliates and shall not be disclosed to any third party without the prior written consent.
- 6.2 Non exclusivity: Both the parties to the agreement are free to have similar arrangements with any other individual, companies or entities.
- 6.3 Nature of relationship: This agreement does not create any agency, partnership or joint venture or franchisee relationship.

1. This CCA shall be in force for a period From **01-01-2025** To **31-12-2027**

1. You Shall Handover Solid waste (Other Than BMW) to Local bodies as per provisions of SWM Rules, 2016.
2. You shall Not mix general solid waste with Bio Medical Waste.

10. Conditions under BMW Management rules, 2016 (As Amended):-

1. You shall adhere to the BMW Generation quantity and storage conditions as specified in Schedule-I of BMW Management Rules, 2016, as amended.
2. You shall segregate and handover BMW to BMW T&D CTF **Passco Environmental Solution Pvt.Ltd., Pune** Strictly complying with the Provisions of Schedule-I and Maintain record of the same.
3. **Cytotoxic Drugs/ Waste:** You shall have separate storage, marked with the symbol of Bio Hazard & Cytotoxic Hazard for outdated, discarded, unused cytotoxic drugs/waste and submit details of Management and Handling of outdated, discarded, unused Cytotoxic drugs in the format prescribed by CPCB which is available on www.cpcb.nic.in along with Annual Report to MPCB with a copy to CPCB before 30th June of every year.
4. **Mercury Waste:** You shall manage the Mercury Waste in HCE in environmentally sound manner (including storage, spilled collection, transportation and disposal) as per guidelines published by CPCB as detailed in document entitled "Environmentally Sound Management of Mercury Waste in Health Care Facilities" (www.cpcb.nic.in).
11. You shall not undertake Modifications/ Upgradation in existing facility without obtaining prior Environment Clearance under the Provision of EIA notification, 2006 Or Consent to Establish from the MPC Board as applicable.
12. Any unauthorized change in Location, Name, personnel, equipment or working conditions as mentioned in the application by you shall constitute a breach of this CCA. In case of any change you shall apply fresh for CCA or amendment as applicable.
13. You shall not Rent, Lend, Sell, Transfer or Close Down the facility or otherwise transport / Handover the Bio-Medical waste generated for any other purpose without obtaining prior written permission of the MPC Board.
14. This Board reserves the right to review, amend, suspend, revoke, or change any of the conditions applicable under this CCA and the same shall be binding on the HCE.
15. You shall maintain records of MPC board Officers visit and shall obey all the lawful instructions issued by the Board Officers from time to time.
16. Any violation of provisions of BMW Management Rules, 2016 as amended shall attract the penal provisions of Environment (Protection) Act, 1986 and Violations under the provisions of Water (P&CP) Act 1974, Air (P&CP) act 1981 shall attract provisions of respective act including closure of the facility and prosecution.
17. This CCA shall not be construed as exemption from obtaining necessary NOC/permission from any other Government agencies as applicable.
18. You shall submit the bank guarantee of INR 2.25 lakhs towards compliance of conditions as specified in Schedule III to The Regional Officer, MPCB, Pune within 30 days. Non submission of B.G. in specified time shall attract revocation of this CCA without further notice.
19. HCE shall recycle 60% treated effluent for secondary purposes like, flushing, floor washing, fire frightening, etc and remaining shall be used for gardening by providing metering system.
20. HCE shall operate ETP & STP scientifically so as to achieve effluent standards as per CCA
21. HCE shall comply with the Environment Clearance for expansion accorded vide dated 05.01.2024

22. HCE shall provide disinfection arrangement to the outlet of the STP and treated sewage shall be disinfected using suitable disinfection method.

23. The industry / HCE shall create an Environment Cell by appointing an Environmental Engineer / Expert for looking after day-to-day activities related to Environment / Pollution control.

5. You shall use only non-chlorinated plastic coloured bags.
6. You shall ensure use of colour coded bins and bags for segregation of BMW as required under BMW Management Rules 2016.
7. You shall not mix General/other Solid waste with Bio Medical Waste.
8. You shall ensure segregation, treatment and disposal of General / Other Municipal solid waste as per Solid Waste Management rules, 2016.
9. You shall pay the charges to authorized Common Bio Medical waste Treatment and Disposal facility for its services as agreed upon during the membership registration or as amended.
10. You shall comply and strictly abide with the conditions stipulated in BMW Management Rules, 2016 as amended time to time.
11. You shall handover Plastic / Metal waste (BMW) to Common Bio medical waste treatment and Disposal facility allocated to you for treatment & disposal or plastic/metal recycler authorized by MPCB for BMW Handling and maintain records thereof & submit to MPCB in Annual report.
12. You shall provide training to all workers involved in handling of bio-medical waste at the time of induction and at least once a year thereafter and maintain record thereof.
13. You shall undertake appropriate medical examination of all BMW Waste handlers & staff at the time of induction and at least once in a year and immunize all involved in management of Bio Medical Waste for protection against diseases, including Hepatitis B and Tetanus, that are likely to be transmitted while handling bio medical waste and maintain the records for the same.
14. You shall ensure use of personal protective Equipment such as Heavy Duty Gloves (Workman's Gloves), Gum Boots or safety shoes for waste collectors, Face mask, Head Cap, Splash Proof Gowns or aprons etc., Disposal gloves by waste handlers.

4. You shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 15 of the Environment (Protection) (Second Amendment) Rules, 1992.
5. You shall comply with the Hazardous Waste (M, H & TM) Rules, 2016 and submit the Annual Returns as per Rule 20(2) of Hazardous Waste (M, H & TM) Rules, 2016 for the preceding year April to March in Form-IV by 30th June of every year to Regional Office, Pune.
6. You shall engage qualified staff/personnel/agency to see the day to day compliance of consent & authorization condition towards Environment Protection.
7. Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of the collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers downstream of the Terminal manholes. No effluent shall find its way other than in designed and provided collection system.
8. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the HCE.
9. You shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.
10. You should not cause any nuisance in surrounding area. You shall maintain good housekeeping.
11. You shall bring minimum 33% of the available open land under green coverage/ plantation. The applicant shall submit a yearly statement by 30th September every year on available open plot area, number of trees surviving as on 31st March of the year and number of trees planted.
12. The non-hazardous solid waste arising in the HCE premises, sweepings, etc. be disposed of scientifically so as not to cause any nuisance / pollution. The applicant shall take necessary permissions from civic authorities for disposal of solid waste.
13. You shall achieve the National Ambient Air Quality standards prescribed vide Government of India, Notification Dated. 16/11/2009 as amended.

14. You shall submit an official e-mail address and any change will be duly informed to the MPCB.
15. You shall observe provisions of E-waste (Management) Rules 2016 & as amended time to time and Batteries (Management and Handling) Amendment Rules, 2010.
16. An inspection book shall be opened and made available to the Board's officers during their visit to the HCE.
17. In case you use/ handle/ generate the cytotoxic waste you shall strictly adhere to the standards/ SOPs applicable and waste shall be labelled specifically as "Cytotoxic Waste" with symbol on waste containers/ bags and shall handover to BMW CTFs.
18. You shall obtain required permissions from competent authority for radio active material user/ handling/ disposal of waste before commencement of such activity.
19. The Energy source for lighting purpose shall preferably be LED based.
20. You shall harvest rainwater from roof tops of the buildings and storm water drains to recharge the ground water and utilize the same for different industrial applications within the plant
21. You shall provide personal protection equipment as per norms of Factory Act 1948
22. You are responsible to submit application for renewal of Combined Consent & Biomedical Waste authorization before 60 days of expiry.



WHERE AS

- A. The D E Society is a Society registered under the Societies Registration Act, 1860 so also is an educational charitable trust, under the Bombay Public Trust Act, 1950 pursuing its objects of imparting formal and informal education in various disciplines.
- B. The D E Society has established an Institute by the name D. E. SOCIETY'S SMT. SUBHADRA K. JINDAL COLLEGE OF NURSING in 2008 (herein after referred to as the said 'COLLEGE') with appropriate permissions from Indian Nursing Council, Maharashtra Nursing Council, Govt. of Maharashtra and affiliated to Maharashtra University of Health Sciences, Nashik.
- C. RAO NURSING HOME which is registered under Section 5 of the Bombay Nursing Homes Registration Act, 1949 having its registered office at B, 691A-1A-1, CTB No. 1897, Pune - Satara Rd, Bibvewadi, Pune 411037.
- D. For mutual benefit, the parties hereto agree that for imparting of practical training and examination of the students as contemplated by the concerned syllabus , the said college shall send students up to its intake capacity, in batches each comprising about 15-20 students led by its faculty members to the said Hospital during the period of their practical training in Medical surgical nursing and according to other terms and conditions enumerated below:



NOW THIS MEMORANDUM OF UNDERSTANDING WITHNESSETH:

1. SCOPE :

The scope of this understanding extends only to deputation of the students by "D. E. SOCIETY'S SMT. SUBHADRA K. JINDAL COLLEGE OF NURSING" up to its intake capacity for all courses, for imparting of practical training in Medical surgical nursing and examination as contemplated by the concerned syllabus for the discipline, in batches, each comprising of about 15-20 students led by its faculty members to the said hospital and other incidental and ancillary matters related thereto.

2. DURATION:

2.1 The duration of this understanding shall be for a period of Three Academic Years i.e. 2023-24, 2024-25 & 2025-26 unless expressly extended.

2.2 Both the parties can cancel or terminate the present MoU by giving Three Months prior notice in writing to each other. In case of dispute, the same shall be referred to the Arbitrator appointed by the parties with mutual understanding, whose decision shall be final and binding on both the parties.

3. AGREEMENT :

3.1 RAO NURSING HOME, hereby agrees and permits the

D. E. SOCIETY'S SMT. SUBHADRA K. JINDAL COLLEGE OF NURSING to depute students up to its intake capacity in batches, each comprising of about 15-20 students led by its faculty members to the said hospital for imparting of Practical training in Medical surgical nursing and Examination of students as contemplated by the concerned syllabus.

3.2 The said college shall acquaint the students with the norms of discipline to be

Followed while on the campus of the said Hospital with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict her/ him from visiting the said Hospital..

3.3 The said college is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said Hospital.



3.4 The parties shall maintain a register of students attending the said hospital for recording the attendance of the students and the said register shall be verified by the faculty members accompanying the batches and any authorized staff of the said hospital.

3.5 The said register shall remain in the custody of the said college and for each experience, it shall be brought to the said hospital for verification by the parties in terms hereof.

4 OBLIGATIONS :

4.1 The D E Society, the said college and the faculty leading the batches shall be responsible for the maintenance of discipline, directives, decorum and good behavior of and by the students on the campus of the said Hospital.

4.2 Since the matter relates to the academic year of the concerned students of the said college, except in cases of gross indiscipline and misdemeanor, the said hospital shall not restrain the students deputed in the terms hereof.

4.3 In the very nature of the matter, the parties here to undertake to extend all necessary co-operation to each other, so that the education of the students of the said College and the treatment and care of the patients of the said Hospital is not hampered.

3. **Cytotoxic Drugs/ Waste:** You shall have separate storage, marked with the symbol of Bio Hazard & Cytotoxic Hazard for outdated, discarded, unused cytotoxic drugs/waste and submit details of Management and Handling of outdated, discarded, unused Cytotoxic drugs in the format prescribed by CPCB which is available on www.cpcb.nic.in along with Annual Report to MPCB with a copy to CPCB before 30th June of every year.
4. **Mercury Waste:** You shall manage the Mercury Waste in HCE in environmentally sound manner (including storage, spilled collection, transportation and disposal) as per guidelines published by CPCB as detailed in document entitled "Environmentally Sound Management of Mercury Waste in Health Care Facilities" (www.cpcb.nic.in).
10. You shall not undertake Modifications/ Upgradation in existing facility without obtaining prior Environment Clearance under the Provision of EIA notification, 2006 Or Consent to Establish from the MPC Board as applicable.
11. Any unauthorized change in Location, Name, personnel, equipment or working conditions as mentioned in the application by you shall constitute a breach of this CCA. In case of any change you shall apply fresh for CCA or amendment as applicable.
12. You shall not Rent, Lend, Sell, Transfer or Close Down the facility or otherwise transport / Handover the Bio-Medical waste generated for any other purpose without obtaining prior written permission of the MPC Board.
13. This Board reserves the right to review, amend, suspend, revoke, or change any of the conditions applicable under this CCA and the same shall be binding on the HCE.
14. You shall maintain records of MPC board Officers visit and shall obey all the lawful instructions issued by the Board Officers from time to time.




